## Presbytery Assembly – March 22, 2022

**Call to Order and Establishment of a Quorum:** The meeting came to order at 5:31 p.m. Moderator Paula Steinbacher and Stated Clerk Olivia Hudson Smith were present. A quorum was established.

## **Assembly Business**

# **Council Part 1**

<u>Agency Review Task Force</u>: Rob Habiger, Council Moderator, presented and updated the work of the Agency Review Task Force, which completed listening sessions of letting go throughout March facilitated by Reverends Evan Amo, Dee Cooper, and Russ Kane. Assembly attendees were asked to respond to "What one comment or question do you have for the Agency Review Task Force?" done in small groups in breakout rooms which were facilitated by the task force members and others. Paula and John offered a responsive lament on the newly adopted value of letting go.

#### Lead Presbytery Nominating Committee (LPNC): Sheri Fry

The Committee reviewed 44 Personal Information Forms (PIF), requested additional information from fourteen (14) applicants, conducted five (5) video interviews, and has invited one person to Denver for an interview. The hope is to bring a recommendation to the May Assembly.

#### Nominating: Dave Goss

The Nominating Committee offered the following names of persons to serve in the roles and for the classes identified beginning in 2022. There were no nominations from the floor. **Approved.** <u>Committee on Ministry</u> To elect Minister of Word & Sacrament Clover Bailey (HR) to the Class of 2024.

<u>Highlands Camp Joint Committee</u> To elect Ruling Elder Frank Middleton (PCOC) to the Class of 2024.

<u>General Assembly Commissioners</u> To elect Ruling Elder Bradley Drenth as primary commissioner and to elect, Ruling Elder Noel Matthews as alternate commissioner to the 225th GA Assembly.

## Presbyteries of Zimbabwe and Denver Partnership (PZDP): Barb Lyons

Despite the interruptions to travel during the pandemic, the partners continue to connect regularly electronically, and the work of the joint ministry is ongoing. The Central Fund projects including cattle, greenhouses, chickens, and fish are up and operating. The Zimbabwe connections through Denver Presbytery mission partnerships and task forces continue to grow. Barb shared a joyous video of the installation of a pastor in Zimbabwe in a remote area which previously did not have a pastor.

## Committee on Preparation for Ministry (CPM): Chris Spotts

Chris Spotts moved that Inquirer Dr. Joseph Edwin Sunder be moved to Candidate. Edwin responded to questions from the Assembly and was moved to a breakout room for discussion and voting by poll. **Approved**. Vice Moderator, John Yu administered the constitutional questions and offered prayer.

## Highlands Camp: Terry Buchanan

Terry Buchanan, Acting Executive Director of Highlands, reported that the camp just completed an ecumenical retreat for youth. The camp is preparing for the summer camping season, registrations are open. They are still looking to fill summer staff positions. He has been contacted by Youth Triennial which was cancelled by the denomination about hosting an event.

## Committee on Ministry (COM): Cindy Cearley

Rev. Clover Bailey was introduced as a new HR Minister Member of the Presbytery coming from Palo Dura Presbytery.

#### Treasurer: Sue Pilcher

Income for the month of February was \$56,042.53. Investment losses during February were (\$82,934.17) resulting in a year-to-date loss on investments of (\$350,235.54). The Presbytery has

not received income from the Colorado Trust but should receive moneys after the end of March. Moneys from the Hayes grant which are restricted funds will move to a special fund for paying salaries for those hired in the incubator initiative.

In the ongoing effort to share our stories and how our race and ethnicities have influenced our faith, RED shared a video of Tom Bacon, a member of Wellshire Presbyterian Church, who serves on Wellshire's diversity committee, and the Presbytery's RED workgroup and Matthew 25 initiative.

## Finance and Property Workgroup: Pat Queen

Motion: Council recommends to the Assembly that New Hope Presbyterian Church be approved to sell a portion of its property for debt reduction, not connected to worship space, parking, or other developed property for not less than 90% of the listing price. **Approved** 

## Stated Clerk: Olivia Hudson Smith

Presbytery Vice Moderator, Rev. Dr. John Yu, will be the guest preacher of the 75<sup>th</sup> Easter Sunrise Service at Red Rocks, at the invitation of the Colorado Council of Churches.
